# MINUTES Council Meeting—March 2, 2023, Page 1

A Council meeting of the Douglass Hills City Council was called to order by Mayor Bonnie Jung at 7:00 p.m. on Thursday, February 2, 2023. Members of the Council in attendance were, Patti Eubanks, Bill Middleton, Matthew Nelson, Neil Sandefur, Denise Scarpellini, City Clerk Clay Porter, City Treasurer Holly Sanford, City Attorney John Singler, Public Works Director Burke Davis were also in attendance. Councilmember Jeff Riddle was absent from the meeting.

OFF DUTY POLICE SERVICES Darrell Spurgeon, of Off Duty Police Services, was present at the meeting. Officer Spurgeon reported that he had received a complaint of speeding on Rothbury Lane from a citizen last month. He reported that the crime maps show little crime in Douglass Hills last month.

### APPROVAL OF MINUTES

Minutes of the February 2, 2022, Council meeting were put on the table. Mr. Middleton made a motion to accept the minutes; Mr. Sandefur seconded by. The motion passed 5-0.

## TREASURER'S REPORT

Mr. Nelson moved to accept the January 2022 Treasurer's report; seconded by Mrs. Scarpellini. The motion passed unanimously 5-0.

<u>PUBLIC WORKS REPORT</u> Mr. Burke Davis reported that the new pickup trucks have been wrapped with the City of Douglass Hills labels and safety lights. Also, the trucks have been equipped with dash cams. Mr. Davis said that the Gatehouse Lane Parking project is going well. Public Works removed two dead trees from the Warren Walker Park. Two new trees will be planted to replace the dead ones.

## **GUEST SPEAKERS-NONE**

<u>COMMENTS FROM CITIZENS-</u> Rick Moreschi, of the Recreation Committee, stated that one problem with the pool is retaining lifeguards. Mr. Moreschi believes that daily passes are the root of problems at the pool. Mr. Moreschi stated that it is difficult to decide pass fees without more information on cost to run the swim pool.

SAFETY COMMITTEE- Mr. Jerry McGraw, of the Safety Committee, stated that the Safety Committee addressed concerns about the painting of crosswalks, stop bars and a centerline on Gatehouse Lane. He reiterated that the City of Douglass Hills must follow the guidelines of the National Traffic Control Manual. The Safety Committee has no interest in painting a center line on Gatehouse Lane. Mr. McGraw has propose sending a letter to Mayor Greenberg, LMPD 8<sup>th</sup> Division, Jeffersontown and Middletown Police Departments, Louisville Metro Council Members that represent Douglass Hill and Commonwealth of Kentucky Highway Department regarding excessive speeding on Gatehouse Lane.

### TREE COMMITTEE- None

**EVENT COORDINTOR-** Jennie Norfleet discussed Muffins with the Mayor being rescheduled due to weather. Mrs. Norfleet asked citizens to like Douglass Hills' Facebook page. Mrs. Norfleet announced that Douglass Hills' 50<sup>th</sup> Anniversary party will be on 10/07/2023. She talked about a contest using Crosby Middle School to design a new Douglass Hills flag.

**RECREATION COMMITTEE**- Councilmember Sandefur spoke about several projects that the Recreation Committee are recommending to the City Council for swim pool improvements. Mr. Sandefur spoke about reports of several problems at the swim pool including staffing, rule enforcement, changing rates for seasonal and daily passes.

#### MAYOR JUNG'S REPORT-

- Mayor Jung encouraged City Council members to submit a budget request for 2023-2024.
- Mayor Jung spoke about the letter to the government officials regarding speeding on Blankenbaker Lane.
- Mayor Jung has estimates to replace the windows in City Hall.
- Libs Paving will begin resurfacing streets in Douglass Hills starting in mid-April.
